What happens now?

After you have submitted this form, Victorian Fisheries Authority staff will be in touch to confirm installation location/s and provide any support you may need (e.g.: working with the land manager if required) and to organise the distribution of your ready-to-install bin/s.

How do we monitor the success of the bins?

An important part of the Seal the Loop program is monitoring the use of the bins and the impact the program is having in your area. To do this, we ask custodians to let us know what the bins are collecting via our online data collection form (a link to this form is on the website).

We would really appreciate your involvement in data collection, as it helps to gain an important insight into how much fishing line is prevented from entering waterways and oceans. We use this information to continuously improve, and to demonstrate how important the bins, and you as a bin custodian, are to protecting wildlife and creating a safe environment for all.
